

# 12th Prospect Portrait Prize 2023

## Terms and Conditions



Newmarch Gallery invites contemporary approaches to portraiture.

### Selection process

The 12<sup>th</sup> Prospect Portrait Prize is a juried exhibition. Members of the Prospect Arts Action Network (PAAN) will assess and select the finalists for the exhibition which opens 8 December 2023. Finalists will be selected on the artistic merit of work and conformation to conditions of entry. The selection panel will consider the work in relation to presenting a cohesive Newmarch Gallery exhibition.

### The Prize

The Prospect Portrait Prize is a non-acquisitive prize.

Prize winners will be chosen from those works selected for exhibition in the 12<sup>th</sup> Prospect Portrait Prize 2023.

- First Prize = \$5000
- People's Choice = \$1000
- Payinthe Award = \$ 500

First Prize will be judged by independent judges solely on artistic merit.

Payinthe Award will be determined by City of Prospect Council staff and Elected Member votes.

First Prize and Payinthe award to be announced at opening of exhibition.

People's Choice to be announced at the closing of exhibition, determined by public vote.

The judges' decision is final and no correspondence will be entered into and no feedback will be given on works entered.

Shortlisted artworks to arrive at Newmarch Gallery no later than **5pm Monday 27 November 2023**

Prospect Portrait Prize Exhibition Opening and Announcement of Prizewinners on **Friday 8 December**

Official opening **6pm Friday 8 December**

**Exhibition dates 8 December 2023 to 13 January 2024**

### Conditions of entry

A separate entry form is required for each artwork.

Portrait artworks can be in any visual medium such as sculpture, digital media, drawing, painting, photography, printmaking, textiles, ceramic, glass, performance, video/film or multi-media (sound and written word can be included). If in doubt please send your query to [admin@prospect.sa.gov.au](mailto:admin@prospect.sa.gov.au).

All artwork entered must be no larger than 2m x 2m x 2m. Size will be a consideration for works in other forms, i.e. performance. Artworks must be supplied ready for hanging or installation and must be able to be installed in Newmarch Gallery by Gallery staff and are subject to a risk assessment.

Entries must include 1 jpg image (2 jpg images for 3D works) of actual work entered. The artists name and the title of the work must appear as the image title file name.

A current one page curriculum vitae (CV) must accompany each entry form.

All images and curriculum vitae will be retained by the Gallery for archival records.

A non-refundable entry fee of \$32 (incl GST) must accompany each entry. More than one artwork may be submitted and each artwork submitted shall be accompanied by a separate entry form and a separate entry fee. Freight and transit insurance costs to and from the Gallery and insurance of work whilst on site at Newmarch Gallery are the responsibility of the artist. Entries must be the original work of the artist and completed after December 2021.

All artworks entered must be available for sale. A 30% (plus GST) commission will be charged by Newmarch Gallery on exhibited artworks that are sold.

ABN or Statement by Supplier form must be provided if artwork sold.

Newmarch Gallery reserves the right to reproduce any works selected for archival, catalogue or publicity purposes.
